Who qualifies for a discounted permit fee?

Blue badge holders, Tri-Anglia members or members of any of the clubs operating from the Boathouse at Whitlingham (which includes the Canoe Club and Norwich Rowing club) are entitled to the discounted rate. Any other clubs that operate outside this remit are not eligible.

Broads Authority Volunteers are also entitled to a discounted fee subject to verification from the Volunteer Coordinator that they are an active volunteer in the applicable year.

Proof must be supplied on application otherwise the full fee will be applied.

What type of proof is required?

A copy of your blue badge which shows the name of the blue badge holder, the registration number and expiry date.

A copy of your membership card or letter/email from the Club/Membership Secretary verifying your membership.

PRIVACY AND DATA POLICY

This privacy notice tells you what you can expect when we collect personal information from you.

This Privacy Policy has been produced in accordance with the Data Protection Act 2018.

The Whitlingham Charitable Trust ("the Trust", "we", "us") shall collect your data from this form and shall use it for administering your car park permit as Data Controller based on fulfilling those contractual arrangements between you and the Trust.

The data shall be shared with the Broads Authority of Yare House, 62-64 Thorpe Road that administers the payments and permits on behalf of Whitlingham Charitable as Data Processor.

Your vehicle registration number shall be used by RCP Staff for the purpose of checking your right to park your vehicle at Whitlingham Country Park. For information about Parking Charge Notifications please go to www.rcpparking.com. The current car parking contractor is RCP Ltd, 15 The Close, Norwich, Norfolk, NR1 4DZ. Broads Authority and RCP Ltd (or any company notified to you as operating or administering the car park and permits in their place) are data processors duly authorised for the purposes intended.

Where you claim any discount for your permit through membership of a local club or other organisation, we will share your name and address with that organisation in order to verify your membership of it.

We will not keep your information any longer than we need to and we will not ask you for any more information than we need.

We shall retain your banking details necessary to maintain Direct Debit payments. Debit and Credit card payment details will be destroyed promptly once your card provider has confirmed the payment.

Where you have indicated your consent on this form, we shall use your data from time to time to provide you with a list of events and activities forthcoming at Whitlingham Country Park. You may withdraw your consent to receiving this information by e-mailing us or by telephoning us using the contact details on this form.
