PRIVACY AND DATA POLICY

This privacy notice tells you what you can expect when we collect personal information from you.

This Privacy Policy has been produced in accordance with the Data Protection Act 1998.

The Whitlingham Charitable Trust ("the Trust", "we", "us") shall collect your data from this form and shall use it for the purpose of administering your car park permit as Data Controller on the basis of fulfilling those contractual arrangements between you and the Trust.

The data shall be shared with the Broads Authority of Yare House, 62-64 Thorpe Road which administers the payments and permits on behalf of the Trust as Data Processor.

The information relating to your vehicle registration shall also be used by Broads Authority staff at Whitlingham Country Park for the purpose of checking your right to park your vehicle and shall be shared with the car park contractor from time to time where reasonably necessary in order to resolve any issues arising through your vehicle registration being recorded by ANPR monitoring. In the event that the car park contractor issues you with a penalty charge notice for a period covered by your permit which you ask us to try and resolve, we will share your data with them. The current car park contractor is Park With Ease Limited of Unit F, The Court Kestrel Road, Trafford Park, Manchester, M17 1SF.

Broads Authority and Park With Ease Limited (or any company notified to you as operating or administering the car park and permits in their place) are data processors duly authorised for the purposes intended.

Where you claim any discount for your permit through membership of a local club or other organisation, we will share your name and address with that organisation in order to verify your membership of it.

We will not keep your information any longer than we need to and we will not ask you for any more information than we need.

We shall retain your banking details necessary to maintain Direct Debit payments. Debit and Credit card payment details will be destroyed promptly once the payment has been confirmed by your card provider.

Where you have indicated your consent on this form, we shall use your data from time to time to provide you with a list of events and activities forthcoming at Whitlingham Country Park. You may withdraw your consent to receiving this information by e-mailing us or by telephoning us using the contact details on this form.
